You can get your BURN PERMITS online!!! They easy and they are free! www.goodlandtownship.org Burn Permits are issued with the understanding that "the fire shall be attended until fully extinguished." Burn Permits are issued for the purpose of burning ONLY natural products—tree limbs, branches, leaves, plant stubble, etc. *It is illegal to burn any type of construction material!*

- Reminder the 2018 Summer Taxes—without interest and penalties—are due in full by **September 14, 2018**. This is the last day taxes are due and payable before interest is added under MCL211.44A. **Office hours that day will be from 9:00 am to 5:00 pm.**
- **There is a drop box available on the pillar outside if the Treasurer/Deputy Treasurer is not in the office.**
- **The Treasurer's Office will be open on Tuesday and Thursday through the Summer Tax Season from 9am-1pm.**
- **Summer Tax Receipts will be mailed out with the Winter receipts as in years previous.**
- The Treasurer's office is currently accepting applications for Summer 2018 Tax Deferments.
