They wish to provide the same service in this area, but Lapeer County doesn't have 40 any such policy. Due to the number of dogs they have, they require a kennel license. They will be 41 installing a wireless fence for containing the animals. The Krasas assured the Commission that they will 42 not have more than 10 animals at a time.
