33 Fee Schedule—needs to be updated to reflect changes in Library charges, janitorial fees, and cemetery
34 burial fees.

35 Computer/Server—still compiling recommendations and bids.

36 School House project—trying to get the Committee together again to research funding sources (grants,
37 etc.) as the property owners would like to have a final decision by July 1, 2017.

38 LCRC—their next meeting is 6/21/17 at 4:30 p.m. Goodland needs to have representatives attend this
39 meeting to discuss the gravel project.

40 2017-2018 Budget Discussion—there was much discussion regarding needs, finances and opportunities to
41 cut costs. A preliminary budget was discussed. Changes will be made and presented to the Board for
