This application **must** include either 1) a survey showing all the current and proposed splits of land or 2) a letter of approval from the Goodland Township assessor stating that the proposed splits would be allowed if in fact a private drive/road is approved by the Goodland Township Planning Commission. This application must also be accompanied with (10) copies of a drawing which fully complies with the Private Driveway Ordinance No. 1304 or the Private Road Ordinance No. 1305. The drawing must be to **scale** and include the entire subject property and everything within 330 feet of the subject property, showing existing and proposed property lines, structures, buildings, road right-of-ways, driveways, points of ingress and egress, parking areas, dimensions, fencing, landscaping, signs, bodies-of-water, and all items listed in Section 4 of the Ordinance for private drive approvals and Section 3 and Section 6 of the Ordinance for private road approvals. The completed application received with fees and stamped *Date Received*, along with all necessary documentation by the Clerk's Office 45 days prior to the scheduling of a hearing date. Fees forwarded to the Township Treasurer. This application will be acted upon by the Planning Commission only after a public hearing is conducted. **FAILURE TO MEET THESE REQUIREMENTS WILL RESULT IN A REJECTION OF THE APPLICATION! PLEASE READ THE FOLLOWING RECOMMENDATIONS.**

It is recommended that personal and or private driveways, which extend over four hundred (400) feet from the center of the road to the nearest part on the principal structure, should provide a **clear** and **unobstructed** turn around area capable of permitting a fire truck to adequately turn around and egress the subject property.
