Road Project

The road project, which began in July of 2015, is to put a new topcoat of gravel on every unpaved road in the township within three years of its start. The monies for the project, \$85,000 per year for three years, is coming out of current revenues, which is the first time in Goodland's history that a major infrastructure project has been funded without additional funds being requested from the taxpayers. The gravel was purchased at a 50% discount from the road commission pit in Burnside and approximately 1/3 of the township road system will be completed each year. The project is on schedule.

Blight Lottery

When blight is recognized, a letter is sent to the property owner. Approximately fifty percent of the time, the problem is solved. When more than one or several instances of blight are noticed in an area, that area is targeted for blight abatement enforcement. After receipt of the first letter the property owner has thirty (30) days to comply. If not, the infraction is reported to the Construction Code Authority for enforcement. The penalty for non-compliance is that a citation is issued at which time a court date is established and fines and punitive action are decided by the judge.

In order to help our residents, we have applied for a scrap tire grant from the DNR, which is monies to collect and dispose of unwanted tires. Residents will be notified after April 1, 2016 for dates and times.

Event Hall

- ◆ Available to residents only.
- ◆ A \$100 deposit is required to reserve event date.
- ◆ The deposit check will remain uncashed and will be returned within thirty (30) days after the event, if there are no messes or damages.
- ◆ General rental is \$150 and will be due no later than seven (7) days prior to the event.
- ◆ Funeral gatherings require ONLY a non-refundable \$50 deposit.
- ◆ Janitor will open and close building for rental.
- ◆ Kitchen may be used for warming foods only—no cooking is allowed.
- ◆ Event hall will hold up to 85 persons.
- ◆ Tables and chairs are available.

Board of Review

The Board of Review is a three-member board, appointed by the township board, designed to review property assessments, hear appeals, and make decisions on poverty and veterans' exemptions. The board is responsible for reviewing the assessment roll before notices are published. Ultimately this board is the final voice for the property holder/tax payer. If a property holder has a complaint he or she must first attend a Board of Review hearing, at which time the board reviews the appeal. Any decision that is made, can only be appealed to the Tax Tribunal in Lansing, MI if this process is followed. Meetings (hearings) are public and posted according to law:

March 8, 2016, 6 p.m. (Organizational and to receive the Roll from the Assessor)

March 14, 2106, 9 a.m.— 5 p.m. (Public meeting for property owners to check their Assessments)

March 16, 2106, 5 p.m. — 9 p.m. (Same as above)

July 19, 6 p.m. – 8 p.m. (for principal residence exemptions)

(poverty exemptions can be handled at any meeting)

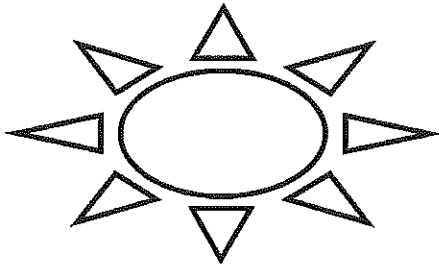

Construction Code Authority

Established in 1978 the CCA issues all zoning and building permits to private and commercial residents, (enforcing ordinances when requested) within the area of its twenty-six-member organization. This intergovernmental agreement brings the members into compliance with Michigan Public Act 230 (every unit of government must have a Building Department). The cooperative ownership of this organization allows the CCA to be self-supporting thereby easing the burden of operation from taxpayers.

Regular board meetings are held on the fourth Thursday monthly at 8:30 a.m., and an annual meeting is held in June to elect board members. There are six full-time and 3 part-time employees.

The main office is in Lapeer at 1075 Suncrest Dr. and a satellite office is in Imlay City at 150 N. Main St..

In order burn refuse on your property, FREE Burn Permits are issued with the understanding that “the fire shall be attended until fully extinguished.” If a permitted burn is found to be **unattended**, penalties could include but are not limited to a \$650.00 fine + a fee per truck used + wages for each fire-fighter called. Burn Permits are issued for the purpose of burning ONLY natural products—tree limbs, branches, leaves, plant stubble, etc. It is illegal to burn any type of construction material!

In 2015, the Goodland Township Board members appointed a Parks and Recreation Committee to oversee the development of a Recreation Plan and to assist in determining preferred parcels of land to seek for future parks. The Committee consists of five members:

The Recreation Master Plan (copies of which are available at the township offices) is a guide for the development of community park land and recreational/educational facilities and locations over the next five years. Additionally, it is a requirement for grant solicitation from the DNR, which is a main source of state funding provided to municipalities for these purposes. Assisting the board is the Saginaw-based planning and development firm, Spicers Group.

A public meeting to discuss the Recreation Master Plan was held on February 9, 2016. Subsequently, the plan was adopted at the February 9, 2016 regular board meeting.

Planning Commission

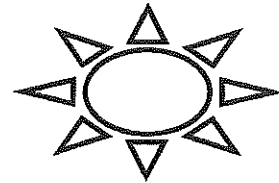

The purpose of the Z.B.A. is to hear appeals, and subsequent requests for variances, when residents cannot meet the requirements of adopted ordinances.

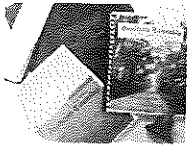
The Z.B.A. meets twice a year or in special meetings when necessary.

Historical Collection

For over a decade the township board and private citizens have been working to preserve the township's historic buildings and records. The Historical Collection resides in a portion of what was once the township offices and recreational/election hall. The room is being used to collect and protect, catalogue, and share historical records, artifacts, and information generated by the township throughout its 160+ years.

This endeavor is being funded almost entirely by private donations and volunteer labor. There are, however, great opportunities on the horizon. As part of the Parks and Recreation plan, moving other historic buildings to the recreational property to "...bring educational and recreation opportunities..." is being considered.

In the meantime, electronically preserving and cataloguing the archival collection continues. While the history room

has been closed for the last several months, work has been continuing and beginning in May, the archive will again be open to the public during regularly scheduled hours. Electronically digitized records and print copies of select documents and manuscripts will be offered for sale.
