Motion by Parsch, seconded by Cischke, to approve Project # 504-009-213800 for a single application of dust control (\$18,563.00 for a single application), Project # 504-009-213801 for double pass roadside mowing to be done 1 time (\$6,161 for single mowing), Project # 504-009-213803 for ditching to be performed at locations approved by the Township Board (Twp. share \$5,000), and Project # 504-009-213802 for brush axe and tree removal to be performed at locations approved by the Township Board (Twp. share \$5,000).
