Supervisor Cischke called the meeting to order at 7:00 p.m. A moment of silence was held and the Pledge of Allegiance was recited.

The purpose of this meeting is to discuss the 2019-2020 Budget, Fee Schedule, Wages, etc.

There was discussion about the budget to prepare for the Budget Hearing in late June. The School House fund has a current balance of approximately \$6,000. Cischke will talk to the Auditor and check with the State to be sure the most recent budget report was accurate when submitted to the Dept. of Treasury and that the Corrective Action Plan requested by the State is fulfilled.

There was a brief discussion of the mowing and cemetery sexton contract. It was the consensus of the Board to defer any decisions until the next, regular meeting.
